

## Fire Stick Agreement of Responsibility and Liability Form

### Community Library of the Shenango Valley Statement of Responsibility

I understand that I must have an HDMI port on my TV and a wireless connection in order for the Fire Stick to work at my home.

I understand that the Fire Stick is my responsibility while it is checked out to me. I agree that I will be responsible for repair or replacement of the Fire Stick if loss, damage or theft occurs. The estimated replacement cost of the Fire Stick is   \$55.00  .

If others use the Fire Stick while it is checked out to my account and loss, damage, or theft occurs, I understand that I will be held liable for any such loss, damage, or criminal acts that may take place.

**I understand that I must return the device to the circulations desk and not place it inside the book drop. If I do so, I am subject to a \$5 fine and may not borrow another Fire Stick.**

I understand that it is my responsibility to make arrangements with the Community Library of the Shenango Valley to pay any and all charges that incur as a result of overdue charges, improper use, loss, or theft of the Fire Stick. Failure to do so will result in civil, and possible criminal, charges. I understand that it is my responsibility to pay for any and all charges and for improper use, loss, theft, including all court costs, fees, and any and all collection and attorney fees.

I understand that no videos/movies/games/apps/music may be purchased via the Fire Stick while in my possession. In the event that any items are purchased by the Fire Stick while in my possession I will be charged a service fee and all items will become the property of the Community Library of the Shenango Valley. I understand that I will be charged **\$5** for each day the Fire Stick is overdue.

I have read the Statement of Responsibility and fully understand its terms and obligations.

## **Guidelines for Fire Stick Lending**

- Patron must have an HDMI port on their TV and a wireless connection in the home in order for the Fire Stick to work.
- Patron must be 18 years or older
- Patron must have a valid library card for the Community Library of the Shenango Valley
- Patron must provide a driver's license or state ID
- Patron must pay all prior fines before a Fire Stick may be lent
- No Patron who has previously been sent to the District Justice may borrow a Fire Stick
- Fire Sticks will be lent for one week with one renewal
- Fines for overdue Fire Sticks are \$5 per day.
- Fire Sticks must be returned to the front desk. Patrons returning Fire Sticks to any of the drop-box locations will be assessed a \$5 fine and will not be allowed to borrow a Fire Stick in the future.
- Replacement Costs:
  - Fire Stick Fire: \$55 (\$40 for Device, \$10 for Case, \$5 Processing)
